## Dear Friends,

Last week one old man passed away in our old age home. As we admit only destitute and poor old people, death is a common occurrence and we see at least one death every quarter. Most of these people never had good food in their life and also they have had too much family tensions. So with old age, death advances very fast. This death happened at 11:30 AM. Our staff went through his records and found out the phone numbers and addresses of his relatives. He didn't have his own son or daughter, but had some other relatives living in a village, which is very near. So our staff first infomed their relatives over phone and then sent word through a person who went to the village and personally informed them. The relatives said that they will come for the funeral. We were waiting for them and every one hour, we made phone calls to the relatives reminding them that we are still waiting for them. They were living just few minutes away from our campus. But till 4 PM, no one came and as we have many others in the campus, especially children, we din't want to keep the body overnight and we started the funeral process at 4 PM, without waiting for the relatives. After the van carrying the dead body passed through the village, the relatives landed in our campus and started a fight with our staff. They were expecting us to wait for much longer.

The fact of the matter is that the relatives have seen the van carrying the body moving out of the village and only after that they started from their house to come to our campus. This is to ensure that the funeral process is over and they need not pay for anything! They also want to ensure that they tried to participate! People don't understand that we call the relatives to attend the funeral only as a mark of respect to the departed soul, not to pass on the expenses to them.

In another case, the old man had his own son. When we called him up and informed him that his father had passed away, he said that he had no time and he 'gave us permission' to cremate the body. But a week later we got a letter from him asking us what we have done with the wrist watch of his father. He wanted us to send it to him! If people don't have time for their own parents, how is a wrist watch is going to help?

Most of the cases, no relatives, sons or daughters come for the funeral. Our staff perform the last rites, taking the position of a son. We have become experts in all types of cremations now Hindu, Muslim or Christian.

All relationships have taken a back seat. We can be related to each other, as long as it does not affect our bank balance. Blood has become thinner than water.

## Gandhiji's Fasts VI

# The Gandhian Hartal-A Wonderful Spectacle!

A Bill with draconian provisions, based on the recommendations of a committee called Rowlett committee was introduced in the Imperial Council of India with the reported purpose of curbing political violence. Some of the provisions of the bill were: detention without trial, abridgement of court procedures, restrictions on the right to appeal and retrospective applicability. This Bill provoked a storm of opposition in the council and outside. The Indian political leaders were unanimous in opposing the bill. The provisions of the bill may not be unfamiliar to us in the contemporary situation, as they are more or less akin to recent MISA or POTA. They were then, as now, justified on the grounds of stemming violence and lawlessness. Rt.Hon.Srinivasa Sastry, speaking in the Council observed, "A bad law once passed is not always used against the bad. In times of panic, to which all alien governments are unfortunately far too liable, I have known governments to lose their heads. The possession in the hands of the executive of powers of this drastic nature will not hurt only the wicked; and there will be such lowering of spirit that all talks of responsible Government will be a mockery." Although Sastriji's talk was intently listened to and his oratory appreciated, eventually the Bill was passed.

During the pendency of the Bill Gandhiji and a few other compatriots were concerned and were exercised as to how to combat it. They conferred at Bombay and formed a Satyagraha Sabha with Headquarters at Bombay, and with Gandhiji as President. Still Gandhiji could not clearly conceive as to how to meet this threat. He left for the South where he felt he was at home. He stayed at the house of Kasthuri Ranga Iyengar and was discussing with people like Rajaji, Vijayaragavachari and Kasthuri Ranga Iyengar though nothing concrete could emerge.

Here is what Gandhiji says about the birth of the concept of hartal.

"While these cogitations were still going on, news was received that the Rowlett Bill has been published as an Act. That night I fell asleep while thinking over the question. Towards the small hours of the morning I woke up somewhat earlier than usual. I was still in that twilight condition between sleep and consciousness when suddenly the idea broke upon me---it was as if in a dream. Early in the morning I related the whole story to Rajagopalachari."

"The idea came to me last night in a dream that we should call upon the country to observe a general hartal. Satyagraha is a process of self purification, and ours is a sacred fight and it seems to me to be in the fitness of things that it should be commenced with an act of self purification. Let all the people of India, therefore suspend their business on that day and observe the day as one of fasting and prayer."Rajagopalachari was at once taken up with my suggestion. The date of the hartal was first fixed as 30" March 1919, but was subsequently changed to 6th April. The people thus had only a short notice of the hartal. As the work had to be started at once it was hardly possible to give longer notice. But who knows how it all came about? The whole of India, from one end to the other, towns as well as villages, observed a complete hartal on that day.

Thus Gandhiji's fast on April 6, 1919 was part of a hartal, along with the entire nation as a matter of self purification preparatory to a Satyagraha struggle.

Gandhiji speaks about the observance of this hartal as a most wonderful spectacle. To us also it seems most wonderful, a hartal with no stout men with tucked up dhotis brandishing wooden logs, and the public closeted in their drawing rooms watching a special TV show!
