# **Staff Training Program:**



# Do or Die

All India Congress committee that met at Bombay on August 7, 1942 passed the momentous "Quit India" resolution. The resolution was categorical that the Congress would extend its support to the allies in the war only if India was granted total independence and not otherwise. Free India would assure all her great resources in the struggle for freedom and against the aggression of Nazism, fascism and imperialism. The committee resolved to sanction, for the vindication of the inalienable right to freedom and independence, the starting of a mass struggle on non violent lines on the widest possible scale.

Immediately following the resolution, Gandhiji was arrested and was confined in the Aga khan palace at Poona. Gandhiji wrote to the Viceroy stating that the summary rejection of the demand had plunged the nation and the Government into confusion. He emphasized that the protection of freedom of China and Russia was the common cause of the Government and the people of India. If the response of the Government to Congress was hasty repression, the only inference could be that it was not so much the allied cause that weighed with the British Government, as the unexpressed determination to cling to the possession of India as an indispensable part of imperial policy.

During the period, with all the leaders in jail, people took law in to their own hand, which was responded to by the Government by ruthless action. More than 150 police stations were attacked, besides other government buildings. Over 30 members of the police force were killed, and a few other officials soldiers. On the other side, even according to government figures, 900 civilians were killed and several injured. The unarmed and leaderless mobs faced the police and military firing on 538 occasions, and whipping sentences were inflicted on as many occasions.

The collective fine on villagers amounted to Rs.90 Lakhs which was promptly realized. Over 60000 persons were arrested. Winston Churchill roared, "I have not become the King's first minister in order to preside over the liquidation of the British Empire."

The Viceroy accused Gandhiji of hypocrisy and alleged that the entire violence unleashed by the people was premeditated and engineered by the Congress led by Gandhiji. Gandhiji refused to accept responsibility. In the face of mindless violence by the Government and the absence of leadership, the people reacted in fury. He said,"The Government goaded the people to the point of madness. They started leonine violence in the shape of arrests." He added that if he could not get soothing balm from the government for his pain, he must resort to the law prescribed for Satyagrahis, namely a fast according to capacity. He proposed to go on a fast for 21 days starting from 9<sup>th</sup> February 1943. The fast would be ended sooner by the Government giving needed relief. The Viceroy did not relent and said that the responsibility for the "consequences" of the fast must rest on him (Gandhiji) alone. The Government was in fact afraid to face the consequences if something should happen to Gandhiji during incarceration. Therefore, they offered to set him at liberty temporarily during the duration of the fast. Gandhiji rejected the offer, and said that if he was freed, he would survey the situation de novo and decide what he should do. He did not want to get released under false pretences. The Government issued a statement attributing motives to Gandhiji and implying that he was threatening to go on fast just to get unconditional release. This and other imputations pained Gandhiji and he went ahead with his fast at the age of 74. During the fast, Gandhiji's condition was going from bad to worse and it was reported that the Government had stocked enough sandalwood to cremate him! Much to their dismay, Gandhiji and the Nation survived the ordeal. On March, 3, as scheduled he broke his fast to the singing of Vaishnava Janato!

It was the same Gandhi-in Chaura Chaura, and now, in Quit India, taking seemingly contradictory stands. But in both the situations it was TRUTH that guided him!
