# Dear Friends,

In each city Sevalaya has a friends group and they took care of all expenses. Children were invited to their houses and very good lunch and dinner were provided. In every city, Tamil speaking volunteers

Thus the children get a very good first hand understanding of how a bank functions, how a post office functions etc.

With a view to creating awareness among the students about Human Rights, a meeting was organised on 05/01/2008. Mr. P.Ezhilarasu, Tamilnadu State Patron, Human Rights Organisation and Mr. K.Murali Chief Organiser of the Human Rights Organisation were the Chief Guests and addressed the students.

Vivekananda Day was celebrated at Sevalaya on 12/01/2008. Ms. Grija Ragavan (Editor, Ladies Special, Chennai), Mr. S.Dhanasekar (Asst. Elementary Education Officer, Ikkadu) and Mr. E.Ganesh Babu (Additional Asst. Elementary Educational Officer, Ikkadu) were the Chief Guests. Prizes were distributed to the toppers in the State Level Open Book Examination on the life of Swami Vivekananda conducted by Sevalaya in which 650 students from 35 schools all over Tamilnadu participated.

Pongal, the harvest festival of Tamilnadu was celebrated for 3 days in the traditional way at Sevalaya. The first day of the celebrations Bogi, was on 14/01/2008. A mini marathon race stressing on "Smokeless Bogi" was organised. 200 Students from 13 schools participated. On 15/01/2008, Pongal was celebrated. A brick oven was constructed in the open ground and Pongal, a sweet dish made of newly harvested rice, milk and Jaggery was cooked in new earthen pots and was offered to Sun God. Mr. Venkatesa Mudaliyar, landlord in Puliyur was the special Guest and lighted the oven offering Prayers to Sun God.

The Third Day is celebrated as Mattu Pongal in Rural Tamilnadu. It is actually a Thanksgiving Day for the Friends of the Farmer-the cow and the ox. Traditionally, Jallikkattu – where a buffalo will be tamed by the youngsters – will be organised. But every year Sevalaya organises Volley Ball tournament for the village youth. This year 16 teams from 10 villages participated. Johnson Volley Ball team from Thiruninravur were the winners and Velliyur team were the runners up. Mrs. Amsa Raja (Panchayat President, Pakkam) and Mr. G.Raveendran (Ex. Panchayat President, Palavedu) were the special guests.

The 59<sup>th</sup> Republic Day was celebrated on 26/01/2008. Mr. P.Ezhilarasu (Tamil Nadu state





Patron, Human Right Organisation) hoisted the National Flag. Mr. S.Immanuel Carter of the District Medical division of the Human Rights Organisation organised a free Eye camp. 640 villagers were benefited. Free eye surgeries were performed and spectacles were distributed.

A concert on Key Board was presented by the students of Ms.Sathya Priya Krishnan on 26/01/2008. It was a new experience for the children who listened to keyboard for the first time. They enjoyed the programme.



# Always the right thing to do...

"Do not worry; Truth will ultimately triumph" a good hearted gentleman was reassuring a silent and steady Gandhian worker (This tribe is very rare nowadays) who was being subjected to the worst of calumnies. The spontaneous response of the Gandhian was not only astounding but it was profound. "Even if Truth fails, I will be by the side of the Truth." asserted he. Truth is a basic virtue, and even while facing insurmountable difficulties, Harischandra did not make any compromise, even though at that juncture he did not have any inkling that Truth was going to triumph.

Harischandra was Gandhiji's role model. Did Gandhiji face any situation when Truth apparently failed? How did he act then?

It was the passing of Black Act in South Africa, when Indians in Transvaal resolved under Gandhiji's leadership that they would not register, subjecting themselves to ignominious conditions. Barring a minority all Indians refused to register, and over hundreds were jailed. At this juncture, at the intervention of a journalist, General Smuts offered a compromise that if Indians would voluntarily register, the Black Act would be repealed. It was just to avoid illegal immigration, it was reasoned. After due consultations with the co-prisoners, Gandhiii agreed to this. There were meetings of Indian community and by and large the agreement was ratified. But a few Pathans led by Mir Alam accused that Gandhiji had sold out the community for a bribe of 18000 pounds. He vowed that he would kill Gandhiji if ever he dared to register himself. Gandhiji declared that he would be the first to register himself.

It was the fateful day. When Gandhiji was proceeding to the registrar's office, heavy blows from a cudgel descended on his head. He was

severely mauled. Blood was oozing out from his lips, and his cheeks were lacerated. Even in that condition what Gandhiji did was to request the registrar, who had arrived on the scene, to bring the papers so that he could register himself first as he had pledged. Even the registrar who was not so friendly to the Indian community suggested that all that could wait. Gandhiji insisted on him to bring the papers. The registrar complied, and while registering, there were tears in the registrar's eyes.

There is a post script to this story. General Smuts had in fact betrayed. The Black Act was not repealed. The Satyagraha was started again. The Indian community made a bonfire of all the registration certificates, and Gandhiji was the first to consign his. Here a very emotionally moving event occurred. Mir Alam embraced Gandhiji and said he was very sorry for having assaulted him. Gandhiji held his hand tightly and reassured him that he never bore any ill will towards him. It was a fitting finale for a 'case study' of truth alone triumphing.

True, truth always triumphs. But true adherents to truth stick to it not because truth triumphs, but because it is always the right thing to do.
