Dear Friends,

Sevalaya has most of its students residing in the Kasuva campus and some of them are staying in various hostels all over Tamilnadu, pursuing their higher studies. All these children land up in our Kasuva campus during holidays. One such student is Ms.Mahalakshmi, who is doing her nursing course in Dindigul, around 450 KMs, south of Chennai. She came to Chennai during this holiday season. As her bus was to arrive at the Chennai bus station at 6 in the morning, we had sent a staff member to pick her up and bring her to Sevalaya. You need to change two local buses and it will take sometime to reach our campus in the village. But that day morning around 6:15 I got a call from our campus in-charge that the girl has already arrived in the campus on her own, as her bus reached one hour before time and she didn't wait for our staff to pick her up. I was happy that the girl could manage on her own but I was also upset that the girl didn't bother to call on arrival, in which case we would have told that our staff was on the way. When I met her that afternoon, I tried to talk tough and told her not to take empty buses in such early hours all by herself, which may not be safe. "You are still a child for us; so don't try all this adventure". The girl was silently listening to me and then she said, "I have something else to tell you".

She told me how she met a boy by name Raja and she is in love with him and wants to marry him. "But, I will marry him only if you permit". I was speechless for a moment I was advising this girl not to travel alone and she is talking to me about her marriage! She is not a child any more. Of course, she is 22 years old! Mahalakshmi lost her mother when she was very young and soon after her father deserted the family.

Some distant relatives brought her to Sevalaya and left her with us when she was a little girl. I am still assuming she is that little girl!

As she has no relatives, conducting the wedding becomes Sevalaya's full responsibility. So we first sent a staff member to Karur, around 400 KMs south of Chennai to visit the boy's home and meet his family members and of course verify the details given by the girl. After getting positive reply, we asked the boy and his family to visit Sevalaya. Then myself and another staff member went to his house again, this time to fix the date for the wedding and pass on our personal invitation to his family and relatives. We explained to the boy's mother that we have hundreds of girls like this and whatever we do for this girl, we have to do it for all. Hence costly wedding presents in terms of gold and silver are not possible. They understood the point and said there is no demand from their side.

The wedding will be conducted on 20/02/2011 Feb, from 9 AM to 10:30 AM, in a traditional Indian way at Sevalaya's Kasuva campus. This is a wedding of a daughter of Sevalaya. So you are her family. Please do attend the wedding and bless the couple.

Gandhiji's Fasts XVI Lalnath Episode

In 1934, Gandhiji undertook an extensive tour of the country soliciting support for the Harijan cause and creating awareness. Wherever Gandhiji went the sanatists staged black flag demonstrations. They used intemperate language, and bombs were hurled at his retinue. All these agitated Gandhiji's followers but Gandhiji was unruffled. He only told the sanatanists that he did not aspire for martyrdom but, "if it comes my way in the prosecution of what I consider to be the supreme duty in defence of the faith I hold in common with millions of Hindus, I shall have well earned it..." On July 15th, Pandit Lalnath, leader of the sanatanists appeared at the venue of the meeting to be addressed by Gandhiji and created a ruckus. There was an altercation and he received a lathi blow on the head. Gandhi soon arrived at the scene and rebuked his followers and then called upon Pandit Lalnath to speak in the meeting putting forth his points of view. In a statement issued to the Press on that day Gandhiji declared his intention to fast. He said," I have now decided to impose upon myself a fast of seven days, to commence on Tuesday noon, the 7th August, that is two days after reaching Wardha, which I expect to do on August 5th next. This is the least penance I owe to Pandit Lalnath and the sanatanists whom he represents. It is, perhaps, fitting that the end (of the Harijan tour) will be signalized by a penitential fast. May it cover all the errors, conscious or unconscious, of omission or commission, of me and my co-workers. The movement will not end with the fast. Let it open with a new and cleaner chapter in this struggle for the emancipation of nearly fifty million human beings from thralldom, imposed in the sacred name of religion. Let it also be a warning to those who are in, or will join the movement that they must approach it with clean hands and hearts, free from untruth and violence in thought word and deed..."

There is an interesting anecdote connecting this Lalnath. When Gandhiji was in Benares, he received a warrant "on behalf of the Lord of Kashi" calling upon him to appear before the kotwal of the Lord and there to be tried for the breach of Sanatana Dharma. Gandhiji asked the young sanatanist who served the warrant as to who gave him the warrant. He replied that the Lord prompted him to arrest Gandhiji. Then Gandhiji asked him that why the Lord did not ask him to obey the warrant. "Because you are a sinner against the Sanatana dharma" was the reply. At this stage, Lalnath appeared on the scene and asked for two portraits of Gandhiji. Gandhiji declined. The sanatanists procured Gandhiji's portrait and publicly burnt it. All the while Gandhiji's followers were watching the scene but they could not do anything as their hands were tied by the pacifist Gandhiji.

In 9 months of the Harijan tour Gandhiji covered more than12500 miles and collected about 8 lakhs of rupees. He summarized his impressions of the tour thus: The impression left on my mind is that untouchability is on its last legs...A demonstrable awakening on a large scale has taken place among the Harijans... I would hope that the savarna Hindus will realize the wickedness of untouchability as it is practiced today and get rid of it themselves, rather than that they should be compelled to do so by the circumstances beyond their control.

Reaching Wardha on August 5, Gandhiji issued a statement: "As I enter upon the seven days' fast from tomorrow, I would like to reemphasize the necessity on the part of the Harijan workers helping the cause by greater personal purification and greater concentration on the work before them."

At the conclusion of the fast on August 14, he wrote, "The fast was primarily and nominally intended for the hurt caused to Lalnath and his friends at Ajmer at the hands of the sympathizers of the movement. But in reality, it is a call to all workers to be most exact and correct in approaching the opponents.'
