# Dear Friends,

Recently near my residence many restaurants have mushroomed. There is a wide variety of cuisine - Pizza, south Indian, north Indian, Gujarathi, Rajasthani, Italian etc. On any day, if we go for dinner, all the restaurants are full and we can't get a table without waiting. There are too many people, some birthday parties are going on, many friends and families have a get-together – if you look for a quiet corner, you will never get it, either for lunch or dinner!

In the last two decades the country has seen high economic growth. Many industries have opened up, new private airlines, many new offices, new cars, etc – all indicating prosperity.

Recently a study report (HUNGaMA report) came out which made our prime minister call it a "national shame". The study was organized by a group of young politicians, artists, directors, social activists and policymakers called Citizens' Alliance Against Malnutrition. This study has revealed that at least 40 percent of all Indian children below the age of five are underweight. Hunger, lack of basic health education, bad sanitation and unclean drinking water are shown as the causes for this situation. Compared to this, in sub-Saharan Africa, the rate of children under five who face malnutrition is 24 percent, according to the United Nations Children's Fund. In China, a growing superpower alongside India, that number is only six percent. One child dies every 15 seconds in India due to neonatal diseases and 20 lakh children die before reaching the age of five.

The country sees over four lakh infant deaths every year within 24 hours of life and over 20 percent of the world's child deaths occur in India - the largest number anywhere in the world.

One in three malnourished children of the world live in India. Another interesting finding from the survey is that prevalence of child malnutrition is significantly higher among children of mothers with little or no education. It was seen that 55 percent of mothers never went to school while 84 percent had never heard of "malnutrition".



So why this divide? If nearly half the children in India are suffering from malnutrition, then what will be our future? We keep talking about growing young population in India and may be in 20-30 years time we will have the largest percentage of youth. If all the youth are unhealthy, what is the advantage of having such large "youth power"?

No doubt this is a national shame, but not doing anything about it is a national crime. Mostly these children will be in city slums, villages, etc. may be in some children's home like Sevalaya. We will have to plan and provide food, health education and provide for sanitation and good drinking water. There are many Government programs like ICDS, mid-day meals, free rice to the underprivileged, etc., but the results show that these programs are not effective. The problem is big – half the children are not getting proper food or clean water – so it needs everyone to participate.

If each one can help one person, then half the country can take care of the other half.

# Stand up and fight!

For spiritual aspirants, there is a danger of straying into distorted notion of some teachings. The maxim, "Resist not evil" is one such. Swami Vivekananda is firmly of the view that evil has to be resisted with all one's might. He does not believe in the fine distinction between evil and the evil doer. In his view it is for a very few enlightened people. For the rest, such discrimination is impossible. He is one with Mahakavi Bharathiyar who exhorted the child to trample upon the evil doer and spit right into his face.

Swamiji said that if a number of us put non resistance into practice, the whole social fabric will fall to pieces, the wicked will take possession of properties and our lives, and do whatever they liked with us.

To his Western Disciples, who raised their eyebrows about Lord Krishna admonishing Arjuna and calling him a hypocrite and coward because of his refusal to fight, or offer résistance, making the plea that nonresistance was the highest ideal of love, here is the voice of Lord Krishna, mouthed by Swamiji. "This is a great lesson for all of us to learn. The extreme positive and the extreme negative are always similar. Of like nature is the difference between resistance and non resistance. One man does not resist because he is weak, lazy, and cannot, not because he will not.; the other man knows that he can strike an irresistible blow if he likes; yet he not only does not strike, but blesses his enemies. The one who from weakness resists not commits a sin, and as such cannot receive any benefit from the non-resistance; while the other would commit a sin by offering resistance. Arjuna became a coward at the sight of the mighty array against him; his "love" made him forget his duty towards the country and the king. That is why Shri Krishna told him that was a hypocrite. "Thou talkest like a wise man, but thy actions betray thee to be a coward; therefore stand up and fight!"

There is a classic episode in the life of Swamiji where he stoutly resisted an offence against him.

One day, when Swamiji was living in a suburb of Calcutta, he met a Police officer, who was his family friend. He greeted Swamiji cordially and invited him for the dinner in the same evening. When he arrived, the host was speaking so many things, but there was no sign of any dinner. Suddenly he lowered his voice, and assuming a menacing look, said,"Come, you had better make a clean breast of it and tell me the truth. You know you cannot fool me with your stories, for I know your game. You and your gang pretend to be religious men, but I have positive information that you are conspiring against the Government. "What do you mean?" asked Swamiji, amazed and indignant. "What conspiracies are you speaking of, and what have we to do with them? "That is what I want to know," coolly replied the Police Officer. "I am convinced it is some nefarious plot, and you are the ring leader. Out with the whole truth, and then I will arrange that you are an approver." you know everything, why don't you come and arrest us and search our house?" Said the Swamiji and rising, he quietly closed the door. Now, Swamiji was a young man of powerful build, while the police officer was a puny wizened creature. Turning round upon him Swamiji said, "You have called me to your house on a false pretext and have made a false accusation against me and companions. That is your profession. I on the other hand, have been taught not to resent an insult. If I had been a criminal and a conspirator, there would be nothing to prevent me from wringing your neck before you could call out for help. . As it is, I leave you in Peace." So saying Swamiji opened the door and went out, leaving the officer speechless and in fright.
