Dear Friends.

One evening, a middle aged man came to Sevalaya campus. An old lady, dressed in a torn sari had come with him. She looked pale and was almost in tears. The man told us that the lady was working as a cook in his house. She stayed with them and he was taking care of her so far. Now the lady has become old and her eye sight is not all that good. So he can't employ her anymore and hence she can't stay with his family. So he was looking for an old age home where she can be admitted. We took down the details and spoke to the lady. She also confirmed whatever the man said. Then we filled up the required forms and admitted the lady in our old age home.

After couple of months, the truth came out. The old lady is actually the mother of that man and not his cook. We found this out when the lady was casually complaining to other ladies that her son never visited her after dumping her with us. When the lady understood that I have come to know of the truth, and fearing that she will be sent out for telling lies to us at the time of admission, she came to me and literally fell at my feet and begged that we should not send her out. I was shocked at this and asked the lady to get up and stop crying and talk to me normally. She said "for all practical purposes, I was only a cook in my son's house. It is a 'lie' that I am his mother. That I was the cook is the "truth". So don't feel I have cheated you. If you send me out, where will I go? My son has not even come to see me in the last two months. He is not going to take me back in the house. He has a good earning; his wife is also working in a nice place. But they don't want me in their house, as I have become old and useless". I assured the lady that we will not send her out. We tried to locate the son, but they had moved out from their place and no one knew where they had gone.

Lions club of Padi-Shenoynagar had organized a

beautiful program recently in the city. They had invited senior citizens from twelve old age homes in and around Chennai and actor Revathy Shankaran sang old tamil film songs and some devotional songs. The grandmas and grandpas came up with many requests for old songs to be sung and Mrs. Revathy Shankaran continuously sang all the songs that were requested for nearly two hours. All the 500 odd senior citizens enjoyed the music and some even danced. Hats off to Lions club of Padi-Shenoynagar and Mrs. Revathy Shankaran for entertaining so many "old and useless" mothers and fathers!

"Is the tree heavy for the earth? Is a branch heavy for the tree? Is a fruit heavy for the branch? Is the kid 'heavy' for a mother?" was one of the songs requested by a grandma. Some of the grandmas were in tears when this song was sung. Where are those kids, who have thrown out these mothers, thinking that they are "unbearably heavy".


We proudly say "mother earth", "mother nation", "mother tongue" etc. Do they have any meaning, if real mothers are treated like this?

Gandhiji's Fasts V

Some times inevitable...

The first ever fast by Gandhiji for a public cause was in relation to a labour dispute of Ahmedabad mill workers. Gandhiji had to intervene in the matter on the request of labour leader, Ms. Anasuyabehn. The Mill owners' representative was Ambalal Sarabhai, a good friend of Gandhiji. In fact he had saved Satyagraha ashram in a crisis situation when it faced closure due to the cutting of its "life line" by its regular donors who were irked by Gandhiji's action in admitting an untouchable family in the ashram. Another curious aspect of the matter is that the labour leader Anasuyabehn was Ambalal's own sister. O! Those were the times, and those were the ways!

The mill owners declared a lock out on February 22, 1918. Opening the mills on March 12" they put a condition that those who accepted 20% increase alone will be admitted. This was unacceptable to the workers led by Gandhiji. Gandhiji thoroughly studied the issue and was of the view that 35% wage rise was reasonable and advised the workers to accept it. But the mill owners were adamant. In the circumstances, workers went on a strike, Gandhiji had explained to the workers the conditions of a successful strike, which included inter alia, that they should not resort to harassing the black legs or resort to violence; and they should not resume work until their terms were accepted by the mill owners, or they agreed for arbitration. The workers took a pledge to this effect...

The strike went on for 21 days. The management did not seem to relent. Workers' morale was flagging... There was a fear that there would be an outbreak of violence. It seemed that the workers may even resume work unconditionally. For Gandhiji it was inconceivable. To him a pledged word is solemn. He was undergoing mental agony. In his own words," Was it pride or was it my love for labourers and my passionate regard for truth that was at the back of this feeling-who can say?"

He heard a voice from among the workers," It is all right for Gandhiji to

lecture us to fight unto death. But we have to starve. "At the very moment, as if his Inner Voice was dictating, Gandhiji announced," Let us both starve in trying to keep our vows....unless the strikers rally and continue the strike till a settlement is reached or leave the mills altogether, I will not take any food." Anasuyabehn was in tears and the laborers were thunderstruck. They begged forgiveness for their lapse and assured they will remain steadfast to their pledge and offered that they would fast instead. Gandhiji advised them that they need not fast and it was enough that they stuck to their pledge. He also arranged for employment of the laborers in construction work in the ashram. It was a refreshing sight to see Anasuyabehn leading the laborers, carrying a basket full of sand over her head. The workers were infused with a new strength.

The net result was that an atmosphere of good will was created all round. The mill owners agreed to refer the matter to arbitration. Gandhiji broke his fast which lasted for three days from March 15,1918.

How does Gandhiji view this fast? He says, "My fast was not free from a grave defect. I enjoyed very close and cordial relations with the mill-owners, and my fast could not but affect their decision. As a Satyagrahi I knew that I might not fast against them, but leave them free to be influenced by mill-hands' strike alone. My fast was undertaken not on account of lapse of the mill-owners, but on account of that of the laborers in which, as their representative I felt, I had a share. To fast against them would amount to coercion. Yet I could not help it. The duty to undertake it seemed to me to be clear."

Axiom: One can fast for his own lapses and those of his followers. To fast against an opponent to influence his decision would be coercion. Some times, it is inevitable, when the duty beckons that one should fast for his/followers' lapses.
