Education

(Bharathiyar Unit)

Mahakavi Bharathiyar Higher
Secondary School is a Govt.
recognised, unaided, Tamil medium
School for classes from Pre School to
Higher Secondary. It provides quality
education 100% free. The school
provides value-based education to
make the children self-reliant and
responsible citizens. Teachings of
Mahatma Gandhi, Swami Vivekananda
and Mahakavi Bharathi are imparted
to the children.

- Free Education from Pre KG to Std XII
- Free uniforms, stationery, note books.
- Free transport for Nursery day scholar children
- Total school strength 1950
- Minimal drop outs (3.8%)
- Centum or near centum results in Board exams (Std X & Std XII)
- Community College offering training in Electrical, AC and Refrigeration, Carpentry, Garments and Beautician courses.

Swami Vivekananda Library

(Including Mobile Library) has over 15,000 books including the complete works of Mahatma Gandhi, Swami Vivekananda and Mahakavi Bharathiyar and also books on various topics like self-improvement, physical and biological sciences, IT and engineering.

- Free Library with a collection of 15,000 books.
- Open to public.
- In a month, the mobile library reaches around 500 people in 4 villages.

Rural Development:

(Mahatma Gandhi Unit)

Sevalaya is a green zone. It imparts environment education to its children and implements the same in the campus. It segregates the degradable and non degradable wastes for disposal.

Solar energy powers 70% of operations in Sevalaya's Kasuva campus.

Organic Farming is implemented in the campus. Cow dung and Vermicompost are used as bio fertilizers. Sevalaya conducts regular workshops to propagate organic farming.

Vinobhaji Goshala shelters dry cows. It also shelters cows yielding milk for consumption by residents.

Kasturba Craft Centre conducts a six month free certificate course in tailoring and craft for poor rural women. Computer classes for poor rural youth and women are also conducted.

Medical Camps: Sevalaya conducts regular medical camps for eye, dental and general check up for the benefit of the residents and villagers.

Homes

(Swami Vivekananda Unit)

Swami Vivekananda Boys Home and Mother Teresa Girls Home (Unaided, Recognized as "Children's Home" under Dept. of Social Defense, Govt. of Tamilnadu)

Presently these homes shelter around 150 children. These homes provide food, education, opportunities for skill development and talent promotion in an atmosphere of love and care.

These children are taken care of till they become self dependent. Many of the children are now well settled in life, pursuing careers as qualified mechanics, electricians, artisans, bank officers, nurses and software professionals.

Sri Ramakrishna Paramahamsa Old Age Home (Unaided, Recognized by the Social Welfare Department, Govt. of Tamilnadu)

It is a home for poor and destitute senior citizens. The home strives to provide dignified living to them in the evening of their lives. 65 senior citizens have made their homes here.

Integrated Campus (Aided, Recognized by the Social Welfare Department, Govt. of Tamilnadu) Sevalaya has been selected by the Govt of Tamilnadu for implementation of its new programme in Tiruvallur District, the Integrated Campus under which 25 destitute senior citizens and 25 destitute children are housed in one campus.

Mahatma Gandhi Medical Centre with 12 beds providing medical facilities to the residents and the neighbouring community.

- Boys Home and Girls Home housing 150 orphan/destitute children.
- Old Age Home housing 60 senior citizens.
- Integrated Campus housing 25 senior citizens and 25 children in the same campus.
- Medical centre with 12 bedded facility.







Maybe because of my hearing so many – and only - good things about Sevalaya?


Maybe I was feeling so happy in my inner soul whenever I had an opportunity to visit Sevalaya?

Managing Trustee's Report

Dear Friends,

Going beyond the silver jubilee is a great experience. Sevalaya has been growing year after year, but as the organization has already completed 25 years and firmly set its foot, the growth rate hereon has to be in a different gear. The 26th year clearly shows that we are on a rapid growth path.

Sevalaya family now comprises 1950 children, 65 senior citizens, 45 cows, 150 staff, 4 locations and a donor community that is spread all across the world.

Major projects completed in the 26th year are:






- 3. Solar Power generation: Thanks to Page Pierre foundation, we have the entire campus, almost running on solar power now. We generate around 48,000 units per day largest NGO installation in south India. This has ensured that the campus will have 24 hours power supply and our computer centre and school can go on without any disturbance during the day. Also the children and senior citizens can have a good night's sleep with the fans running throughout the night. This minimum comfort was out of our reach for the past few years now, as we had a very bad power crisis.
- 4. New 12 bedded free hospital: A new hospital was inaugurated on 20th December 2013. This has vastly improved the medical care we can offer to our people and the neighbouring community. Doctor and nurses take care of the medical requirements of the residents, school students and the villagers. Many medical camps are held with the help of city hospitals regularly. The Medical Centre project is sponsored by Mr. Subramaniam and family of Singapore.
- 5. English Language lab: Chennai Willingdon Corporate Foundation sponsored the English language lab. The language lab system developed by the British Council was purchased and our teachers were trained to use it. Along with the regular English classes, the lab is also used by high school classes. As there are more audio- visual lessons, the students find it interesting.
- 6. More Montessori environments:
 Chennai Willingdon Corporate
 Foundation also sponsored
 additional Montessori kits. The
 numbers in Sevalaya's kindergarten
 is swelling every year as Sevalaya
 is offering high quality education
 totally free of cost and admission
 is mostly made only at entry level.
 To cater to the needs of more
 and more kindergarten kids we
 plan to increase the Montessori
 environments every year.
- 7. Additional libraries: Now Sevalaya has a separate library each for the high school, the primary school and the staff. Best selling self improvement books are the highlight of the staff library; good subject-oriented books are stocked in the high school library and colourful story and games books in the primary library. 

- 8. Water Doctors: Clean drinking water is a basic requirement and if made available to the children, it will prevent many health problems in the future. Mr. Bikam Chand Jain has sponsored Water doctors, (heavy duty water purifiers) have already been installed in our schools and dining hall.

Awards:

Afforestation drive in Sevalaya is as old as its inception and all visitors to Sevalaya's Kasuva campus will notice that the entire area is a green zone. It has also carried out many projects to create awareness among students, villagers and general public in Thiruvallur district. Its regular campaign for smokeless Bhogi has resulted in making the villages around Sevalaya a smoke free zone on Bhogi day. All this was noticed by the district administration and Sevalaya won the "best green campus" award from the district collector and also from the district forest department. in the previous years. This year we got noticed at the state level and Ministry of environment, Government of Tamilnadu selected Sevalaya as the best NGO working for the cause of environment for the year 2012-2013. The award was presented by the then Minister for Environment, M.C.Sampath, at a State Government function held on 5th June, 2013, World Environment Day.

Our children won the "Design for Change" award for the third time. Around 25,000 schools participated from all over the world and Sevalaya's project was selected in the top 20. The award was presented in Ahmedabad, on 18th Jan 2014 by Kiran Sethi, head of Riverside school.

Swadeshi magazine selected Sevalaya for its annual "Dhruva award". The award was presented by Mr. Raja Ramakrishnan, past district Governor, Rotary club on 19th Oct

Sevalaya was selected as the "NGO of the year" by Public Relations Council of India. The award was presented in Mumbai by Dr. Vithal Venkatesh Kamat, Executive Chairman and Managing Director of Orchid group and Rajashree Birla, Director of Aditya Birla Group on 14th Feb 2014.

Medical camps

In association with many leading hospitals in Chennai, Sevalaya took experts and specialist doctors to the interior villages, organized many camps besides camps in the Sevalaya hospital. Each camp had hundreds of beneficiaries, of free surgeries and medicines. Many spectacles were distributed free of cost. Significantly, many villagers were detected having cancer and hepatitis and treatment was organized with the help of city hospitals. Without such camps, these villagers would have never known the medical problems they had.

Value education book in Tamil released

Sevalaya's national award winning moral education has now come out in a book form. It was released on 14th Sept, 2013, by Mr.B.V.Ramanaa, the then Minister for Revenue, Government of Tamilnadu. The book is available as a free download from Sevalaya's website. Leading magazines wrote highly positive reviews about this book, highlighting that the book was available free of cost. Demand has come from all over the globe – an Indian night school in Australia and a Tamil night school in NewYork were among the many callers who found this book very useful to teach moral lessons to kids.

Lectures in various schools and colleges on BGV

Sevalaya arranged programmes in various city schools and colleges and addressed students on the philosophies of Mahatma Gandhi, Swami Vivekananda and Mahakavi Bharathi. The students were invited to talk and the best performing students were given awards.

British Council programme

Sevalaya has been taking part in British Council sponsored school exchange programmes every year. This year our teachers R. Vijaya and S. Sumathi went to Cunningham Hill Junior school and experienced taking classes in a UK school. Similarly, teachers from that school visited Sevalaya and there was a useful exchange of ideas to improve education.

100% results once again

It has become a tradition that our school students excel in their academic performance. This year's results were: 100% pass in both 10th grade and 12th grade. More than one third of the class got above 80% and almost all were above 60%.





Governance

Sevalaya's Board of Trustees and advisory board consists of socially minded professionals with key competencies in areas such as Child Care, Education, Counseling, Moral Education, Information Technology and Management functions. - Bharathi Team Leads our educational initiatives, and includes primary school, high school, higher secondary school, community college and library.
- 2. Gandhi Team Leads our rural development activities, and includes village development activities, craft centre, agriculture and goshala.
- Vivekananda Team Leads our support for needy, that includes Old Age Home, Boys Home, Girls Home, Integrated Campus and Medical Centre.

These functional units are supported ably by Public Relations and Administration Teams.

Right to Information

Though as a private charitable organization we do not come under Right to Information Act, we believe in transparency and on our own accord, we publish our financial information, bank details about all activities, names of people associated etc. on our website. Donors, well wishers and any member of the public can access all these data on our website.

Annual Strategy Meetings

One of the unique features of Sevalaya is the Annual Strategy Meeting held every year before the start of

the new academic session. As early as February/March, all the residents of Sevalaya's Old Age Home, Children's Homes, students in our school and staff working in the various units are asked to write briefly what they think Sevalaya did well in the current year, what could have been done better and what they feel should be done in the coming year. Inputs from 'Visitor's Feedback' diary which is maintained in a prescribed form is also considered. Ideas are also obtained from many donors. Specific questionnaires are designed for each stakeholder segment and they fill it and send it back. The Managing Trustee then consolidates these ideas which are then discussed in the Annual Strategy Meeting. The management and staff then distill them into focus areas, objectives and action plans. Based on this, an annual calendar is prepared, which breaks up the activities day wise. This exercise makes each employee of Sevalaya willingly own responsibilities and be more committed to his/her work, instead of work being thrust on them. This makes each of them a partner in the progress of Sevalaya as a whole.

Weekly report by the Unit heads are based on this action plan. At monthly meetings of the Managing Committee where the trustees, advisors, centre heads and the unit leaders participate, action plans are thoroughly reviewed and followed up to completion.

Sevalaya publishes a monthly Newsletter and an Annual Report which includes the audited Accounts. Both are circulated to all donors and well wishers. The report is also available on the website - www.sevalaya.org.

HR

The consistent and unqualified success of the organisation is, without a doubt, due to the dedication of the entire staff who give their all with 'service' as their watchword. The organisation recognises this selfless service attitude of the staff, with suitable programmes.

Although as a voluntary organization, we are exempted from contributing to Provident Fund, we have a Group Superannuation policy covering all employees completing one year of service. We have also covered the life risk of our employees under a group term insurance policy.

The staff are trained on an on-going basis in academic and personality development areas to ensure their skills remain up-to-date. They are also encouraged to pursue continuous education and several staff members have availed and are availing support facilities offered for further studies.

Volunteers

The staff of Sevalaya are well supported by a team of volunteers who come and share their time, energy and creativity, expecting nothing in return but the pleasure of having done the right thing. There are foreign volunteers, including gap-year students, who come and stay for a period of 3-12 months and work on specific programmes. There are also volunteers who come as and when time permits and help out in any area the need is felt. Corporate employees typically come on weekends to take 'fun' classes for the students. This year we had many volunteers from SCOPE, Shell, HUL, Lionbridge Technologies etc. taking part in our activities. Many institutions such as Anna University, IIT Chennai, Presidency College, New College and Soka Ikeda College come on NSS Camps for a week and take up various activities. Social Work and MBA students come on their academic project work and spend couple of months at Sevalaya volunteering their services.

Donors

Sevalaya does not receive any Government grant, except for the Integrated Campus project. Today it runs on donations made by well wishers. These donations which form the life blood of the organisation could range from a small one-time amount from an individual to large amounts given regularly by funding foundations. The donor could be anyone from a local person who lives a couple of streets away to a Foundation based in the USA or Europe who have heard of and seen the good work being done and the growth achieved by Sevalaya consistently year after year. The organisation, on its part, extends its policy of non-discrimination to its donors too. Every donor, small or big, has the same place in our hearts, and receives all periodic communication regarding the activities, successes, financial status and plans. It is our way to keep each and every donor apprised and to ensure transparency. Hence, as a policy, we do not publish a "Major Donors List."

Future Plans

The success of Sevalaya in Kasuva village has been noticed, followed by request for replication in many parts of the country. We already have centres in three villages. In addition, we have started preparations to start a free community college (vocational training

center) in Thirumalai Vaiyavur, 70 KMs south of Chennai. This is likely to come up by end of 2014.

Round Table and Ladies Circle have sponsored the construction of a basket ball court. The construction is in progress and the facility will be ready by August 2014.

In the pipeline is a free University for the benefit of orphan, destitute and poor children.

We thank all our sponsors, donors, well wishers, media, Government officials, visitors, volunteers – all who have contributed to this growth of Sevalaya over the past 26 years. We very strongly believe that Mahakavi Bharathi, Mahatma Gandhi and Swami Vivekananda are guiding us in our activities and it is only because of the power of their inspiration that Sevalaya has reached such heights and gained such strength and recognition.

Going forward, that is also the source of our confidence.

Medical Centre

A CRUCIAL MEDICAL OUTPOST

Kasuva village where Sevalaya set up its operations in 1988, is a remote village 42 kms west of Chennai city and 22 kms away from the head quarters of Tiruvallur district. The village never had even the basic medical facilities, forcing the people to go to the district head quarters for medical treatment. The nearest Public Health Centre at Puliyur is 3 kms away and functions only from 8 AM to 1 PM. To mitigate this situation a medical centre was started in 1994 at Sevalaya which is know a 12 bedded hospital.

Such a context makes the Medical Centre a crucial medical outpost in its surrounding geography.

Already, the Centre has proved very useful to the elderly as well as the young residents, as also the neighbouring population. As Nagarajan, the old age care taker recollects, "There were so many nights when we had taken the



elders to the medical centre when their BP used to go high and for their asthmatic attacks. Medical centre was a boon to us during the nights and we used to do the first aid and then take them to the hospital in Tiruvallur".





Community College

AN ESCAPE ROUTE FROM THE DEAD END OF LIFE

Garment manufacturing has 23 students, some of them attending classes with their little kids. Carpentry has 3 students while Electrician trade has 30 students, AC and refrigeration has 15 students.

Community College is Sevalaya's latest initiative for inclusiveness through informal education. Functioning since February 2014, it is proving to be an unexpected ray of hope for rural youth who have had to forego formal school education, for whatever reasons. No doubt, the dropout rate in the Sevalava school is remarkably low, but those who fail to finish school do not qualify for admission to ITIs that offer vocational courses. This realisation led to the setting up of the Community College which does not hold lack of formal education against a candidate.

The accent is on making the students competent and employable. The training is practical in its orientation. Industry experts are being roped in to give practical tips through guest lectures. Partnership with industry is seen as integral to the unique value addition, be it through industry visits, internship or placements. Importantly, Sevalaya's training

comes packaged with grooming, including etiquette, functional English and communication skills as also customer servicing skills.

Of the five trades, beautician course has 24 students, from teenaged girls to married women with no educational qualification.







Energy Conservation

GREEN SEVALAYA PROJECTS

Solar power harvesting: Solar light and heat represent an undepletable and massive energy source. Faced with a grim power situation, Sevalaya turned to this natural, non-conventional energy source to meet the needs. Thanks to Page Piere Foundation, the dream to solarize the entire campus has been nearly realized. Now all the residents in Children's Homes, Old Age Homes, staff residences and guest rooms have the comfort of fans on warm nights, as also solar heated hot water. Most importantly, children can study, not affected by power disruptions.

Efforts are on to cover the remaining facilities, Girls hostel and Integrated campus, to make Sevalaya 100% solar powered.

Kitchen fuel saving: Perennial dependence on petroleum products to meet the rapidly growing demand of the large community kitchen at Sevalaya is a large concern. Sevalaya's initiative to find long-term energy alternates resulted in the introduction of 'bio-mass stove', 'bio-gas plant' and







activation of 'steam boiler with preheated water supply through solar water heater. By introducing the 'bio-mass' stove with 'wood waste compressed cakes – Brickquettes', we are now able to shrink the kitchen fuel expenses from Rs. 2044 per 3 days to Rs.156.
