Dear friends,

SEVALAYA has completed two successful years in its service to the needy children. We take this opportunity to present to you a detailed account of our activities.

Most of the present day social/political problems in our country are caused by mis-guided youth. Youth of a country is its asset. The standard of country is the reflection of the standard of its society which in turn depends on the standard of the youth. To ensure the blooming of a good society, the children of the society should be provided with a conducive environment and better opportunities. Strong belief in this idea brought us a group of like-minded youth together. We formed SEVALAYA to provide the basic needs of food shelter, clothing, medical aid and education and a loving atmosphere to the unfortunate orphans.

Donations Are Exempted From Income - Tax

SEVALAYA started functioning on 29th May 1988 with 5 children. Now we have 25 children in our care. We provide food, clothing, shelter, education and medical aid to our children absolutely free of cost. The institution is run on donations by the philanthropic public.

We admit children without making any discrimination on the basis of caste/colour/creed/religion/sex/nationality. We collect all relevant information from the guardian or the well wisher of the child to be admitted. We also get it certified by a responsible citizen from that locality. We conduct medical check-up for the child to be admitted. We also make personal enquiries and admit the child only after ensuring the genuinity of the case. We propose to take care of the children till the time they can take care of themselves.

The Local (TIRUNINRAVUR) panchayat members have unanimously passed a resolution for the allotment of one acre of puramboke land in survey No. 1/1 in the village border, for the construction of hostel and school buildings on 30-4-89. We are still awaiting a positive reply from collector's office.

We thank our Hon'ble Social Welfare Minister Smt. SUBBULAKSHMI JAGADESAN for being with us as chief guest on 17-12-89 and gracing the occasion of our first annual function. We also thank our M. L. A. Shri T. R. MASILAMANI for taking part in the celebrations. We also thank our Lions club of Alandur Adambakkam friends for donating Rs. 1001/- towards the purchase of a T.V. set for the orphanage. We also thank our advisory committee members and local panchayat members who blessed the children.

We try to organise tours for our children and take them to places of interest. On 1. 1. 90 we arranged a trip to Mahabalipuram. The children had a very good time and they enjoyed it very much.

Republic day celebrations were conducted on 26th Jan 90. Mr. Thennarasu, President, Thiruninravur D. M. K., Mr. Theivasigamani of Congress (I), Mr. Venkatesan, Executive officer of Thiruninravur Town Panchayat and Mr. Viswanathan, President Thiruninravur Town Panchayat were our chief guests on that

occasion. All the ward members of Thiruninravur Town Panchayat spoke on that day and promised to take active part in the developments of Sevalaya.

Sevalaya conducted a seminar on social service on 18. 2. 90. Dr. M. S. UDAYAMOORTHY, Dr. RAVIRAJ, Lion KANDASWAMY and Mr. RANGA RAMANUJAM were the chief guests. About 35 youngsters attended and benefited through the seminar. The response for the seminar was very good. We plan to organise many more such meeting in future.

Leo club of T.Nagar conducted 'Dine with Divine' programme with our children on 15-7-90 and they had lunch with our children on that day.

Staff of M/S Cameo Computers sponsored sports day for our children on the eve of Independence day and the prizes were distributed to the children on 15. 8. 90 by Mr. JAGADE-ESANAR M. A , who was the chief guest on the occasion.

Lions club of Alandur - Adambakkam arranged a 'Dine with Divine' programme and members of the Lions club had lunch with our children on 9. 9. 90.

Management of Bharathi college, Thiruninravur donated pens & pencils to our children on the occasion of their First Annual Celebration.

Lions club of Mambalam visited the orphanage and spent a day with our children.

Deepavali was celebrated well by our children. Madras Youth Welfare Association arranged for special meals for our children at Hotel New Woodlands on the eve of Deepavali on 14.10. 90 and presented a set of dress to them. Lions club of Alandur-Adambakkam, staff of Unit Trust of India, Madras and Leo Club of Greater Town presented crackers and distributed sweets to the children for Deepavali. Mr. Kandaswamy, ward member of Thiruninravur Town Panchayat presented dress to our children on eve of his 46th Birthday.
