

Central to Sevalaya's growth and expansion has been responsiveness to felt needs. At the same time, need being felt everywhere, any opportunity that came its way anywhere, led to establishing operations. A lead is validated through need analysis, before a Centre is established.

The CSR laws made in 2015 turned out to be a favourable headwind for establishing new centres. The sponsoring corporates funding CSR projects would prefer that the changes their funds make be close to their operations. They can keep an eye, and their employees can participate, creating an empathetic attitude, partnering their company in a good deed.

2015 marked a new chapter in Sevalaya's expansion: Kindhearted people donating their land/building to Sevalaya. This is significant, as it reflects the trust of people, including strangers, in Sevalaya, to entrust the organisation with the task of fulfilling their unfulfilled wishes. Each such act becomes a vindication of the way Sevalaya operates using a high moral compass and efficiently delivering to the intended beneficiaries.

The following pages are a pictorial directory of our Centres, throwing light on their operations.

## 1. KASUVA. 1988

The then President of the Sivanvoyal Panchayat offered his house on a monthly rent of ₹ 50. Then the Thiruninravur Panchavat offered 1 ½ acre land free. But soon it became clear that getting possession required bribing. So the plan was dropped. Murali and his team of 60 collegues in TCS donated for 6 months' and 1 1/2 acres of land was bought in Kasuva. A hut was built to accommodate 25 children, who were sent to neighbouring schools.

Over the years, the centre grew to 18 acres. There is a school giving free education to 2,180 disadvantaged students, a library, a community college, hostels for 100 boys and 100 girls, an old age home for 70 and a gaushala, a medical centre, organic farms, and staff quarters.









## **S Inbavel**

S Inbavel shifted from another High School to Sevalaya for his 11th and 12th Stds, encouraged by his mother, who was convinced it would help him ahead. His favourite subject was Mathematics. He was a topper and he helped other students in studies. He did well in quiz, debate and oratorical. On the difference in Sevalaya, he says: "The lessons were creatively explained, I understood and could score"

Then tragedy struck: his mother passed away on 21st February, 2023. Sister Kalpana, on completing her graduation, took on the family chores. Meanwhile, he scored 556/600 at the 12th Std. He got admission for studying B Tech in Artificial Intelligence and Machine Learning in Rajalakshmi Engineering College. His father being a daily wager, he didn't have the means to pay the fees. Sevalaya, through corporate donors has arranged the funding. Inbavel's dream is alive!





Long term Sevalaya Advisor DK Oza, former Chief Election Commissioner, alerted about a tailoring class in a building built on Government land, that had ceased operations. Strangely, the villagers demanded rent for use of a building that wasn't theirs! Tailoring classes were resumed by Sevalaya in 2011, then shifted to Uthiramerur.



## P Kaviya

Life changed for Perumal and his family when his body suffered a paralysis. A mason who had earned for the upkeep of his family, he spent 40 days at a Tambaram hospital, accompanied by wife Shanthi. Elder son Dinesh, a 2nd year BSc Mathematics student, started doing AC repairs part time, to support the family. Dinesh and his 16-year – old sister had to manage the household, including cooking.

The trauma changed Kaviya. A happy-go-lucky girl till recently, she has become serious in studies, in her 8th Std. One reason was the Tuition centre at Vadanallur. She credits S Devi for that. "Teachers explain all subjects very well. Already I am getting 90 plus in English and Tamil" she says. She is determined to climb above the 70 marks range in other subjects.

## **3. MAMBAKKAM. 2016**

In line with the preference of PPG Asian Paints Pvt Ltd, the donor, Community Colleges were started in Mambakkam, Sunguvarchatram and Thirubuvanai in Puducherry. Thus was born the Mambakkam Centre.

# 4. THIRUMALAI VAIYAVUR. 2016

On 0.84 acres of land, offered by Ambattur Clothing Factory, Sevalaya runs this nursery. A 70X35 Sq ft greenhouse was sponsored by Sevalaya's long time donor M J Annapoorna in memory of her beloved husband M J Krishna, a nature enthusiast. Half of the 6,000 saplings planted every year comes from the nursery.



## **5. AMBATTUR. 2017**

In 2017, Sevalaya started a community college in Ambattur, offering Tally, basic computer applications and E-publishing.

Tally has seen batch sizes of 40 to 45 students, with half that for basic computer applications. Over the last 6 years, in 15 batches, this centre has trained over 560.

## **7. THANJAVUR. 2017**

K Muthuramakrishnan, then an Advisor of Sevalaya, donated 2 empty plots (8 cents) to Sevalaya. The construction of a 2,000 sq ft building was funded by Petrofac and LIC. 20 destitute elders are residents of an old age home in the name of his father Gandhi Ashram Krishnan.







#### Naganathan and Nagalakshmi

Naganathan was born in 1940, in a weavers' family in Paramakudi, Ramanathapuram District. His father stopped his studies after his 6th Std, not having the money to pay his fees. He joined his father, weaving cotton sarees, around 12 a month. The owner would pay ₹ 12.

When he was 26, he married Nagalakshmi, his relative, 10 years younger. Nagalakshmi was never sent to school. They had three children, Gayathri, Saroja and Murali. Gayathri was adopted by Naganathan's childless elder brother. In the 1980s when mechanization threatened handweaving sector, families migrated in droves. The couple left with the two younger children, and no money.



They tried their luck in Thiruchirai and Tharasuram, switching to silk weaving, finding a benevolent business owner.

Younger son Murali became a weaver as a child. He had two children. Then tragedy struck. Murali was diagnosed with brain tumour and died in 2022.

With no income except what Murali's widow Geetha could earn through weaving, the old couple decided they will not be a burden to Geetha. In November 2019, they got themselves admitted here.

At the end of a life full of struggle and strife, they are thankful for a peaceful life. A hip injury and a metallic piece inserted gives Nagalakshmi regular pain. But Naganathan needs no medicine except vitamins. Looking back at the past brings up memories of relatives who ignored them. Instead, they pin their hopes on Murali's son Jagannathan who will complete his B Tech in 2 years. And... they have each other.





## 8. SUNGUVARCHATRAM. 2018

With the approval of PPG Asian Paints, the donor, Mambakkam community college was shifted to Sunguvarchatram for easy access for the students.

Kowsalya B and Sangeetha P



A BA degree in Tamil Literature through contact classes didn't fetch Kowsalya any jobs. Meanwhile, she got married and found husband Karthik's salary not meeting their needs. "Do you know computers?" was the question at all places. So Kowsalya joined the 4 month training in computers. She manages to send Rubesh (3 years) for his LKG class and receive him back. Vigneswaran (1 year) cries when Kowsalya leaves for classes. A job should be around the corner, Kowsalya believes.

Sangeetha got her BE Computer Science in 2020, got married to





Pandyan, a machine operator, in 2021. Moving to Sunguvarchatram, the couple found expenses mounting, including a ₹ 6,000 rent. So she joined

the Computer classes, confident to get a job and a better standard of living. Sevalaya has so far placed nearly 1,000 trainees in the last 4 years.



## 9. ZAMIN ENDATHUR. 2018

Long term supporter of Sevalaya, D V Sridharan offered his land in Zamin Endathur in 2019. Realising that it was inadequate, he bought an adjoining plot, to make it a total of 25 cents.

With donations from D V Sridharan, Akhil Johri, Nikhil

## **PK Gopal Raja**

PK Gopal Raja was born in Rajapalayam in 1936, got married when he was 26, lost two sons and then his wife. Disappointed, he left Rajapalayam and his bitter memories, tried odd jobs and then settled to work with a Mohan Swami in Valluvar Sabhai for 30 years, serving and cooking. Those years, he visited many religious places including Haridwar, Kashi and Dwaraka, for peace of mind.

Then a fall injured his hip. Massages and oils from Puthur helped somewhat. Then an acquaintance got him admitted at Sevalaya's old

age home at Kasuva in 2019. Then he became part of the new facilities at Zamin Endathur, as content as he was at Kasuva. At 87, Gopal Raja enjoys good health, except for a walking stick that is his extension. "I get food, dress, accommodation and medical support. I get respect, and a convenient life. I have no family worries", says Gopal Raja. He has good eye sight and reads Dinamalar and Valluvar books, loves bhajans. "I mostly keep to myself. I don't trouble others".

Gopal Raja recalls the excitement of Indian Independence and the 75 years since then, including lots that has changed.

#### Bharathi K

In 2018, Bharathi got married to Kumar at 24. He used to sell spices. They had two children, Mahalakshmi and Rohith. Those were happy times. Then Kumar had kidney trouble. Allopathy, Siddha, Homeopathy, Dialysis, all tried in vain. Kumar passed away on 25th December, 2021.

Bharathi's brother called her home. But she was determined to stand on her own feet, than stay as a guest. She had a tailoring machine before her marriage. That became her refuge. She started stitching women's dresses and blouses. Then she joined Sevalaya's Community college at Zamin Endathur and started stitching Sevalaya school uniforms. That fetches her ₹ 8,000 to ₹ 9,000. With that she manages the expenses of Mahalakshmi who dreams to do fashion designing, and Rohith who wants to join the army.

Life is tough, but she braves it. "I have to be brave in front of the children", Bharathi asserts.





## 10. RAVANA SAMUDRAM. 2018

In 2018, R S Nallaperumal of Ravanasamudram donated his 10 cents land and a building. Since then, Sevalaya has been running a Community College, offering training in Computers and Tailoring. 7 Batches in tailoring and 5 in computers have made 150+ women employed.









## Najeeba M

Najeeba M did her BA English from Salem in 2018. Her father Mohammed Sikandar is an employee with a grocery shop chain present in multiple locations. His employment in the Salem branch facilitated her college education. Her degree didn't get any job. Any case, her father didn't want her to work. But following his transfer to Gudalur, Najeeba joinied Sevalaya's Community College, first for Computer course, and then for tailoring.

That training changed things for her. She started running a Xerox shop, and added typing, e payment of EB bills and other e- services. Then she got married in 2021. Her husband Abdul Samathu did not mind her working. She then got a contract job as Office Assistant in the local Panchayat office. The money is small, but she believes she can get a better job based on the experience.



## 11. THIRUBUVANAI. 2018

Thirubuvanai in Puducherry became Sevalaya's first Centre outside Tamil Nadu. Sponsored by PPG Asian Paints Pvt Ltd, it became a location for a Community College.



## 12. UTHIRAMERUR. 2019

Tailoring and Computer classes were started in Vadanallur village in 2011. Then the Centre was shifted to Uthiramerur town, greatly improving access. (Sponsor: Gurukrupa Foundation, USA)







## Lakshmi N

Lakshmi got married to Ramesh in 2012. Then it turned out that Ramesh was mentally sick and marriage was hoped to cure him! Then it was suggested that a child will cure it. It didn't. The boy was born with mental issues. And Ramesh would wander off often, and the last his family saw him was in 2014. Meanwhile, Lakshmi did house work in multiple houses including that of a sympathetic advocate who allowed her son Yadesh to be kept with her, while at work.

Then she heard about the 4 month free tailoring class at Sevalaya. Once her mother-in-law and relatives went to school to take her son away. Alerted by the class teacher, she rushed to school and foiled the attempt. She lives in a crumbling house, but that's all she can afford, with the money she earns from stitching uniforms on a machine gifted by a donor, even while managing to find time with Yadesh. Tailoring keeps her mind away from anxieties.





## 13. ERAHARAM. 2019

A building constructed on Government land in Eraharam has been the venue for free food distribution (anna daanam) a couple of times a year, by Sankari Sastha Trust. Otherwise in disuse, this building was taken at free of cost to start a tuition Centre. The attendance had grown from 45 to 75.

Since 2020, Sevalaya has been running medical camps jointly with Anbu Hospital of Kumbakonam MLA G Anbazhagan.



#### Yazhini M S

In 2017, Yazhini's parents put her in a CBSE school in Kumbakonam for her KG. Elder sister Poonkuzhali was already doing her 5th Std there.

Then tragedy stuck, in 2018: their father Manimaran, who was an editor in a reputed news channel had some unexpected set back. Unable to face it, he took his life. The shock and despair were followed by realism: mother

Saranya took the responsibility for the two young daughters on her shoulders. She started working in a spice packing enterprise as Machine operator.

With no money for the fees, both girls were shifted to a Govt school. The events were traumatic especially for young Yazhini who found the shift from CBSE to Govt school, and the switch from English to Tamil medium, intimidating. Lost and drifting initially, she tried to recover.

Then, in 2020, both the girls joined the Sevalaya Tuition Centre: free, and within walking distance from home. The company of children proved a balm for Yazhini's stressed mind. The patient teaching methods helped her grasp things that eluded her in school. Says Yazhini; "Maths is more complicated for me. Here, my Tuition teacher writes on the board and explains. So I now can understand. My marks have improved, Before joining tuition, I used to get 40% Now I get above 70%"



## 14. URAPAKKAM. 2021

T Radhamani of Urapakkam lost her husband Thirumurthi a few years ago. In 2020, she donated her house in Urapakkam to Sevalaya for programmes to benefit the underprivileged in surrounding areas.



## **15. DHARMAPURI. 2021**

The Dharmapuri Centre fulfils the wishes of long time supporter V Manoharan. He donated his two-storey house at Dharmapuri. It now houses an Old Age Home, as a homage to the memory of his late wife Shanthi.



## S Bhavani

Bhavani was the eldest of five children, born to farm hands in Avadi. None of them went to school. She got married to Subramani, a farm labourer. She doesn't remember the year. The couple had three children. Mala died young. Elder son Raja died 6 years ago, yielding to cancer, after visiting so many hospitals. Within 6 months, Subramani passed away.

With her only surviving daughter Uma not wanting Bhavani living with her, Bhavani sustained herself as a daily wager. After 5 years of struggle, when she lost all hope, she went to a police station seeking help. The Police Inspector directed her to Sevalaya's Kasuva Centre. That was in April 2021. There she had happy times in the



midst of so many children around.

In 6 months, she was shifted to Sevalaya's Old Age Home at Dharmapuri. Walks, daily visits to a nearby temple, some games, some television are part of her day. Being tall, she also has an additional duty: water the flower plants placed at a height.



## 16. GUDALUR. 2021

A major healthcare institution in Gudalur, started and run by a Doctor couple for the welfare of the tribals, became part of Sevalaya in 2021. Dr Lakshmi Chettur ran the institution for nearly two decades, after the demise of her husband, Dr Herbert Herring. With advancing age, she chose Sevalaya to continue the good work of Samaritan Gramodharan Samithy, including the hospital.

Sevalaya has added tailoring and tuition classes, benefiting the neighbourhood including tribals.

## Sangeetha Manickam and Lakshmi Kuttan

Sangeetha Manickam and Lakshmi Kuttan belong to the Kattunayakkan tribal community. Born and brought up in Bennai village, both their parents are daily wage earners.

Both dropped out of school in 11th Std and 12th Std respectively. Not exposed to outside world, they joined Sevalaya's community college located in front of Gudalur Bus stand, for tailoring. Sevalaya provided bus passes for both and the Tailoring Instructors gave them self confidence. They found new friends, reducing their diffidence from having lived secluded lives.

Course completed, Sangeetha met the Centre head Priyadharshini S R, wanting to continue her schooling. She now awaits commencement of a new term.

Lakshmi Kuttan has decided to go to work. She also hopes to work from home, if only she were to receive a sewing machine as a gift.



K Balasubramanian, an ex banker handed over to Sevalaya a vocational training college his Trust was running, along with a two storey building by the sea shore and not far from Marina beach. It caters to Tsunami-affected fishermen families and others including migrants.

The community college now has 15 tailoring machines and 11 computers.

A free medical clinic and a tuition centre are run here.



After failing once, in the 4th Std, Tamil Selvan seemed headed for another loss of year in his 8th Std. He failed in all subjects, in the first term. That is when his classmate told him about tuition classes at Sevalaya. Tamil Selvan bartered his 4 to 6.30 pm games for tuition. Tuition teacher Monika explained things and for the first time in his life, Tamil Selvan understood Maths formulae and problem solving. He expects 70 marks in English, at the Annual Exams that just got over. There is a new confidence. And respect. Class toppers who avoided him now call him for combined studies. At home, too, father Muthuraman, a painter, and mother Amuda, who works at a residence full day, do not nag him to study. Future plans? IT perhaps, he speculates...

Younger brother Mukundan, in his 4th Std, also attends Sevalaya tuitions. His marks have tripled, from around 10 out of 40, to the 30's.

The people of Kiloy suffer from poor transportation. With the nearest Primary health centre 6 km away, the need survey showed up healthcare as a top priority. The Medical Centre operates in the evenings.

A Community College has also commenced operations.

## Manjula

"I'm Manjula, a resident of Kiloy. I had diabetes for past 10 years. The last 2 years, I have been suffering from foot ulcer due to my uncontrolled diabetes. I went to various doctors but could not get a cure.

"Then I visited the Medical Centre in Kiloy. The Doctor showed deep concern about my condition and examined my foot. He advised some life modification, gave medicines and did daily dressing. After 45 days of treatment, the wound is fully healed."









## 23. VENGADU. 2023

The 2,400-strong population of Vengadu village near the industrial town of Sriperumbudur is engaged in unskilled labour like housekeeping, security and casual jobs, with the women engaged in MNREGA.

Under a model village initiative funded by KONE Elevators & Escalators India Pvt Ltd and implemented by Sevalaya, vital infrastructure has been added.

The Health clinic treats 40 patients daily, on an average. Thanks to the daily output of 2,000 liters from an RO plant, the entire population now has access to drinking water. The community toilets now offer unprecedented hygiene and dignity. Over 20 children attend and benefit from the Tuition Centre.

## 24. THILLAIYADI. 2023

A Rangaraj, President of Thillaiyadi Panchayat offered premises to run a clinic in Thillaiyadi. It fitted with Sevalaya's long standing desire to honour Thillaiyadi Valliyammai. A freedom fighter in South Africa, she was an ardent follower of Gandhiji. She lost her life at the age of 16, due to the harsh treatment she suffered in prison.

This has proved a boon to the remote village. The clinic treats 40 patients a day on an average, with a similar number reached by the mobile medical van.





Dhanabalan, an agricultural laborer and his wife Jayalakshmi took their Engineering student-son Venkatesan to the Poraiyar Government Health Centre 5 kms away. "Three days passed but the high fever wouldn't come down. Another 3 days in a private hospital, but no improvement.



One night, things got worse... with shivers and all, we rushed him in an ambulance, to hospital. Venkatesan had Typhoid, undetected Typhoid", says Jayalakshmi, reliving the nightmare of a week.

"If Sevalaya's Medical Centre was open then, it wouldn't have happened. Now such a situation won't happen", says Jayalakshmi, who stays within a short walk of the Centre.

Indumathi has been asthmatic from childhood. Her wheezing intensifies in winter months, leaving her desperately struggling for breath. The only way has been to rush to the Poraiyar Government Health Centre. A bus

comes every 2 hours. The wait and the bus journey make it worse for her.

Now she rushes to the Sevalaya Medical Centre. The nebulizer gives her instant relief. The Centre is a boon to her and her two sons who are also asthmatic.

## 25. THATHANUR. 2023

Under a model village project, implemented by Sevalaya with funding from KONE Elevators & Escalators India Pvt Ltd, major infrastructure has been added in Thathanur village in Sriperumbudur, Kanchipuram District. An RO plant is already functional. Besides 4 toilets in the neighbouring school, 3 Community toilets each for men and women have been constructed in the village of Kalmedu nagar.

The Medical Centre functions from 2 to 5 pm on weekdays. The Tuition Centre will provide free support to the government students studying from Std I to VIII.



## Chandra Masilamani, Thathanur Panchayat President

Chandra Masilamani has been the President of Thathanur Panchayat, not very far from the industrial town of Sriperumbudur. Though geographically not very far from urban Chennai, the villages that encompass the Panchayat have been grappling with deficiencies in basic amenities and social infrastructure: drinking water, roads, educational institutions, toilets...

Not a single newspaper enters the villages. Internet is a moody presence. Television is the only window to the world. There is no graduate or teacher in the villages. Some youngsters work in factories.

Understandably, she is relieved







that many of these needs have been addressed through a recently launched model village programme. The RO water plant has proved a real boon. Water from the village ponds have been badly contaminated, with a reading exceeding 1000 TDS (Total Dissolved Solids). That only source of water was the cause of regular diarrhea and obstinate skin infections. For the first time in their lives, 170 families now get safe (15b TDS) drinking water from the RO plant.

Open defecation has stopped, with the construction of 5 toilets each for men and women, in Kalmet Nagar. The local school children are freed from the embarrassingly smelly old toilets. Children of the only primary school in the Panchayat use the Tuition centre, where education is rendered the fun way. With poor bus service, the Medical Centre is already getting well utilized.

Keeping an eye on all the facilities, on behalf of his mother is, Purushothaman, Panchayat Vice President during 2011 – 16.

The range of services offered have also diversified, impacting the lives of many thousands of lives.

With a passionate staff of 325, Sevalaya embraces the timeless ideals of Bharathi, Gandhi, and Vivekananda. Together, we continue to forge a brighter, more inclusive future for all, leaving no one behind.

#### **New Projects**

Many new projects were sponsored by corporates/ funding agencies/ individuals to improve Sevalaya's infrastructure and facilities, support the education of the children, enhance the living conditions of the children/ elders and making quality healthcare accessible to people in remote villages.



carried out by Sevalaya consistently over the years. Sevalaya upholds a policy of non-discrimination towards its donors. Every donor, regardless of the amount contributed, holds a special place in our hearts and receives regular updates on our activities, achievements, financial status, and future plans. This commitment ensures transparency and keeps all donors well-informed. As a result, we do not publish a "Major Donors List" as part of our policy.

Sevalaya does not receive any Government subsidy, except for the Integrated Campus initiative and a portion of the children's home expenditure. (The Integrated Campus project is a venture by the Social welfare department, Government of Tamilnadu, wherein 25 senior citizens and 25 destitute children are accommodated in one campus. The Government provides partial funding for this endeavor. Sevalaya was chosen by the Government to oversee this project in the Thiruvallur district). Sevalaya has also been selected by the District administration to operate the Reception Home - a temporary shelter for children rescued through Child Helpline, until their cases are heard

and they are either reunited with their families or moved to Children's Home. However, we do not receive any subsidy for this project. Government funding constitutes approximately 3% of the overall budget, while the remaining 97% is derived from donors.

#### **Right to Information**

Although, as a private charitable organization, we are not bound by the "Right To Information" Act, we strongly believe in transparency. Therefore, of our own volition, we willingly disclose our financial information, bank details, activity details, and the names of individuals associated with Sevalaya on our website. Donors, well-wishers, and the public at large can access all this information on our website. Sevalaya publishes a monthly Bulletin and an Annual Report, which includes audited Accounts. These documents are shared with all donors and well-wishers, and they are also available on our website www.sevalaya.org.




